### **8:38 Class of 2023 Council Elections Hearing**

- JudBoard ruling on 2023 elections issues
- Mallika Pajjuri appealing JudBoard Decisions
  - Want council's input on the ruling
    - May have implications after this elections cycle
  - She believes that there were multiple violations during the election
    - As detailed in the enclosure
- Roy Kwon: JudBoard sees no conflict of interest as engage vote matches official tally
  - Motivation behind joint ballot ticket doesn't make sense to him
- Mallika: Joint ticket was never expressed as an option beforehand
  - Joint ticket typically unofficial and voted on by write-in
  - Asked Jacqueline and Wesley directly about the joint ticket issue
    - Received no clarification about why this was never expressed as an option
- But elections commission can enact special rules without oversight
  - Something that could be changed if council believes it should be
- Council members would like to see all the evidence if possible
  - Danielle will work with Roy to get the information
  - We will revisit the topic at the next council meeting
