9:10 PM JudBoard Bylaws

Bylaws sections are close to being finished; Fiona C. and Shelly Ben-David describe bylaws

- 5 sections include: Purpose, Composition, submission and acceptance of cases, working on cases, ruling on cases, and appeals
- Purpose
 - o Resolve conflicts that may arise in UA
- Composition
 - New change being proposed; Reserve Pool they will represent the board as a person

- Submission & Acceptance of Cases
 - o If one JudBoard member deems a case nonfrivolous, then it will be reviewed
- Working on Cases
 - o Self-recusal is encouraged in the case of a conflict-of-interest
 - Hearing process involves a series of deadlines pertinent to the case; people involved, not JudBoard, are culpable for finding the evidence in a timely manner
 - Each side will have 30 min, including opening statements and questions; ruling will be discussed between 24 and 5 days later

Ruling on Cases

 JudBoard should attempt to find a consensus; Chair of the Board is responsible for sending out decisions

Appeals

- o In the case of new evidence, the case goes back to JudBoard;
- Bylaw violations will be reviewed by Council with the possibility of impeachment and then to a Board derived from the Reserve Pool;
- Disagreement in interpretation will initially go to Council and then to a Board derived from the Reserve Pool

Reserve Pool System

- o Fiona C. says that there are still questions regarding this body of people
- o Reasons for a Reserve Pool
 - Conflict of interest
 - Appeals may require a new set of individuals
- Options:
 - Outgoing president nominates both JudBoard individuals and reserve pool
 - IFC, Panhel, Dormcon, and dorm judicial boards form the reserve pool; possibly disproportionate representation
 - Members of Council each nominate one individual and then the number of members of the reserve pools will match the number of Council members

Feedback/ Comments

- o Danielle G. adds that members should be acknowledged
 - Council: Jaya, Albert, Yara, Kate
 - JudBoard: Shelly, Roy, Eric
- Fiona wanted to clarify that edits are still being made, so vote will likely be at next Council meeting
- Kelvin G. has concerns about involving other organizations in the JudBoard appointments;
 - He wonders what sort of documentation would be required and feels that independence in appointment may be more beneficial
 - Kelvin also prefers the lack of Council presence (especially in cases of new evidence) unless necessary (mishandling)
 - Fiona adds that the misinterpretation issue should have an additional step to vet individuals but does not want the process to be overly tedious
- Stephanie Z. was curious if there was a process to determine which members of the reserve pool would be selected in the case of an appeal or conflict of interest
 - Fiona replies that they normally exclude anyone who was previously involved for selection

Options

- Generally, positive reception to appointment through in option 1
- However, many council members unofficially voted against Option 2, which involves IFC, Panhel, Dormcon, and dorm judboards to form a reserve pool
 - However, Jaya K. still feels that randomization would avoid conflict of interest and Jaya feels that IFC is very experienced in handling cases
 - Miana S. expresses that the dorm and IFC/Panhel chairs handle cases of different natures than that of JudBoard

- Shelly B. feels that reserve pool is more of a safety net than a frequent necessity
- Stephanie Z. explains Panhel judicial board, but she explains that one individual from each chapter is selected; however, she adds that a proportionately smaller number of cases are dealt with than the aforementioned organizations
- Shelly B. adds that Maseeh board usually handles cases individually; Summer
 V. adds that she has no knowledge of any handling of cases by Maseeh
- Sarah E. adds that the Dormcon judboard has not been active for some time
- Fiona C. wanted to get a sense of the activity of judboards: Afeefah K. adds that McCormick Judboard is active, but handles more complaints than iudicial issues
- Yara K. also feels that a recommendation system could be implemented, and therefore, the endorsement would not necessarily be required
- Danielle G. is wondering about the timeline of recommendations;
 - Fiona C. says that if no one has people to recommend (if it is not required) then there will be a lack of endorsements
 - Fiona feels that the outgoing president could nominate people to the reserve pool; they could be nominated both independently and from the organizations to supplement the number of applicants

9:39PM Student Leaders on Leave

- Danielle G. adds that leaves of absence (LOAs) will likely drastically increase this year
 - Yale University announced that unenrolled students may participate in clubs as both members and leaders
 - Yale wanted to avoid LOAs from impeding on extracurricular involvement
 - No one is paying for student life fee which removes a point of differentiation from enrolled and unenrolled students

 - David Randall, Senior Associate Dean for Student Support and Wellbeing
 - MIT Senior Leadership
- Danielle and Yu Jing spoke with ASA leaders about new rules
 - 50% of executive board will no longer need to be MIT students (excluding the president and treasurer)
 - Organizations will still need registered students serving as President, Treasurer, and financial signatories
 - MIT students on leave may continue to participate in MIT activities that are open to the MIT community
 - Megan X. wonders if there are two co-presidents and one is unregistered; Danielle responds that one student would officially be president, but the other student would be involved in running the organization

- Roughly 23 no's and 3 yeses. However, Danielle G. adds that this number is by no means representative of the MIT population

- UA Leadership Positions
 - Positions
 - Principal and Assistant Officers
 - JudBoard
 - Stand and Ad-Hoc Committee Chairs
 - Election Commissioners
 - Off Campus Rep (in general UA Council voting members are determined by their respective governing documents. However, there is an exception for Off campus rep)
 - Danielle G. wonders about Council stance on committee members serving while taking a LOA;
 - Sarah A. feels that there is no reason to prevent unenrolled students from being committee chairs, especially given the specificity of the situation
 - Afeefah K. feels that turning over leadership will not be productive, and feels that this should be a temporary policy
 - Nico S. wonders if there will be a distinction between an on-campus LOA versus off-campus LOA
 - Danielle feels that discontinuity of experience is fairly generalized
 - Stephanie Z. worries that being on leave may prevent students from dedicating time to their position (as they will not be spending time on classes)
 - Yu Jing C. adds that while this change is not permanent, it will set a precedence for the future
 - Megan X. wonders how the ASA rules apply to UA; Danielle adds that UA is unaffected
 - Fiona C. wonders if policy may depend on positions, in regards to loss of community and effects of social distancing
 - Megan X. prefers to have UA officers to be currently enrolled students; if UA is representing all undergraduates, then there should potentially be students on LOA involved
 - Stephanie X. feels that because such a significant percentage of students will be on leave; it may be helpful to include representation from students on LOA
 - Nico S. asks if there are any positions that require officers to be on campus or registered.
 - For example, Nico mentions that he is on the commencement committee, so his position is tied to his enrollment
 - Danielle feels that the UA education committee is discussing similar issues.
 - Furthermore, Danielle feels that the issue largely pertains to institute committees
 - Megan X. feels that cases should be dealt with on an individual basis to determine that the person on leave has the necessary time to devote to their role

10:00 PM Emergency Disruption Clause

- Significant Disruption
 - o Danielle mentions that the UA definition includes full-time students
 - Faculty governance committee has a significant disruption policy (put into place in order to change the grading scheme)
 - Kelvin G. describes policy 2.102 for significant disruption which delineates extreme cases that would lead to a decision such as this.
 - Changes must abide by a list of criterion including: confirmation to recommendations of administration and health of students
- Where could it have helped?
 - Nominations

- Institute Committee
- JudBoard
- Election Commission
- Elections
 - UA President and VP
 - Class Council
 - Off Campus Rep
- Where can it still help?
 - Membership
 - Include LOA students as UA Members (for leadership)
- Where it can hurt?
 - Bad actors
 - Stipulations should limit abuse of policy
- Kelvin feels that the faculty governance policy would be replaced by UA specifications
 - https://facultygovernance.mit.edu/rules-and-regulations#2-102
- Sam A. wonders who would make decisions about what denotes significant disruption
 - o Danielle adds that the president would consult with Council and make a decision
- Megan X. wonders if faculty stops significant disruption, would UA follow suit?
 - Danielle feels that UA would probably make a similar decision, but not necessarily be tied to faculty decisions
 - Danielle adds that even if academic groups return to normalcy, student groups may still require significant disruption circumstances
- Gauging interest
 - o No council members gave response.
- Danielle wants an official vote to approve UA officers looking into the issue
